 Summer Fire Season: June 1 – August 31
 *A campfire is to be no greater than 2' by 3' and is reserved for ceremonial purposes (scouting events and back yard events).
 -Hibachis, propane & charcoal grills, and chimineas ARE ALLOWED and are not considered open burning.

RESTRICTED OPEN BURNING
 Spring Fire Season: February 15 – April 30
 Burn Hours: 4:00 pm – 12:00 am

OPEN BURNING
 September 1 thru February 14
 - Open burning is reserved for grass, brush, and normal tree trimmings.
 - It is ILLEGAL to burn pallets, construction materials, garbage, rubbish, etc.

The governing authority is the local fire code which requires 50 feet separation from a structure.

There is **NO OPEN BURNING** in the town limits of Purcellville, Round Hill, Lovettsville, Leesburg, or Middleburg regardless of time of year or season.

Agricultural burning is restricted to 1,000 feet from an occupied structure or highway.

Commercial land development (pit burns) require a FM permit and may have other separation requirements (usually similar to agricultural burning).

Fires MUST be attended at ALL times, with provisions for control available.

Fire must not be added to or stirred after midnight and must be fully extinguished at midnight if not attended.
